## 1. Obligations of Dispatcher

- 1.1 **Services Provided.** Dispatcher will handle all paperwork and communications (phone, fax, email) with shippers and brokers to secure and tender freight shipments ("Cargo") for Carrier's transportation under Carrier's authority.
- 1.2 **Invoicing.** Dispatcher will invoice the broker on behalf of Carrier for each load and provide copies to Carrier. Carrier remains responsible for collection of all freight charges.
- 1.3 **Liability.** Dispatcher shall not incur any financial or legal liability for the transportation of Cargo; Carrier alone is responsible for payment collection from shippers or brokers.

## 2. Obligations of Carrier

- 2.2 **Authority.** Carrier authorizes Dispatcher to sign rate confirmations, invoices, and related documents solely to secure Cargo and facilitate billing.
- 2.3 Compliance & Liability.
  - Carrier will comply with all applicable federal and state motor-carrier regulations.
  - Carrier is liable for loss, damage, or liability arising from transportation of Cargo.
  - Carrier will indemnify and hold Dispatcher harmless from any claims, suits, or damages related to Carrier's operations under this Agreement.
     2.4 Term & Termination. This Agreement continues until terminated by either party with \_\_\_ calendar days' written notice.

## 3. Limited Power of Attorney

Carrier hereby appoints Apex Cargo Dispatch LLC as its attorney-in-fact to:

- Transfer and sign any documents necessary for load bookings;
- Accept loads and discuss billing/accounts with brokers or direct shippers;
- Receive payments on Carrier's behalf.
